## I. INTRODUCTION

IVONNE, Inc. ("IVONNE") is in the market for an experienced supplier who can source and install a multi-room sound system for its clinic.

#### II. BACKGROUND

IVONNE is a boutique **4-Room (836 sq ft)** Permanent Makeup, Skincare, and Laser Clinic registered in Canada, operating in the City of Ottawa, Ontario.

IVONNE is owned and operated by verified Metis Citizens, and 1st generation Canadians. In its 6th year of operations IVONNE provides Permanent makeup, dispensed skincare, and PicoWay laser treatments including laser tattoo removal and skin rejuvenation.

IVONNE is known for its strong professional relationship with its regulators, partners, and suppliers.

## **III. GENERAL REQUIREMENTS**

The sound system and supplier should meet all of the following requirements:

- The supplier should be in good standing with its professional associations and memberships including BBB and (Google Business) Review platforms;
- The supplier must be in compliance with all provincial and municipal regulations including employer safety regulations, building codes, and policies of Place de Ville.
- The supplier must be willing to perform its work, including site assessment, installations, service, and clean-up outside of clinic hours (i.e. before 9:00am and after 6:00pm on weekdays and Saturdays; and any time on Sundays)
  - The proposed sound system must:
    - be able to stream from both consumer and commercial grade music streaming services via an app or browser controlled access.



- Must be appropriately sized to provide ambient, background music only, across 4 rooms areas.
- Must integrate into an Unifi UDM Pro gateway device.
- Must fit within the server at our location.

# IV. GENERAL TERMS AND CONDITIONS
